



Installation

- 1. Remove driver's side headlight bucket:**
 - Open hood
 - Remove (1) screw and plastic retaining clip.
 - Disconnect headlight and set aside.
- 2. Mount speaker to bracket:**
 - Remove three (3) bolts from back of D-44 speaker. (SEE FIG.2)
 - Align holes in bracket to speaker and re-install bolts.
 - Torque bolts to 30 in-lbs.
 - Speaker wires must exit bottom of speaker. (SEE FIG.1)
- 3. Position bracket and speaker:**
 - Bracket will align with pre-existing holes in vehicle frame. (SEE FIG.3)
- 4. Attach to vehicle:**
 - Use 1/4-14 x 3/4 self drilling screws, flat and split washers. (SEE FIG.3)
- 5. Route wires:**
 - Route wires so they are not in contact with any sharp or abrasive surface.
 - Fasten securely to nearby features.
 - Refer to siren installation manual for wiring connections.
- 6. Replace Headlight bucket.**
 - Replace headlight to its original position.
 - Re-install plastic fastener and screw.

IMPORTANT!
Speaker must be mounted with drain hole/wiring exit facing down.
Failure to do so will void warranty!
